CANON LAW INSTITUTE SET FOR USD JANUARY 12-22

The fifth annual Tribunal Practice and Chancery Procedure Institute will be held January 12 through 22, 1981, on the campus of the University of San Diego.

The Institute is designed for Catholic pastors, associates, religious, and lay persons wishing to improve their expertise in canon law relating to marriage. It is sponsored by USD's School of Graduate and Continuing Education and the Canon Law Society of America (Western Region).

Advance registration is required, and a fee of \$135 is charged. Room and board is available on the USD campus at an additional cost of \$25 per day. For information, call 293-4585.

The Institute will have two levels, according to a USD Continuing Education statement. The first level will be for those without extensive formal education in canon law, and will provide an overview of procedures and jurisprudence applicable to marriage cases. The second level is for canonists who have had some training and experience.

The Institute's program will deal with such areas as: Jurisprudence, Administrative Procedure, Formal Procedure, Theology of Marriage, Theology of Law, Chancery Procedure, and Case Studies.
