#### PROFESSIONAL MEMBERSHIP

The College Entrance Examination Board has notified the College for Women that it was elected to membership in the College Scholarship Service Assembly at CEEB's October 24 meeting in Chicago. The main purpose of the Assembly is "to serve as the major forum within the College Board for consideration of policies and courses of action within the field of the economic aspects of college attendance;" Mother Bourret will be the CW representative to the Assembly. We will be included in the CEEB College Information Booklet which lists all member colleges.

#### PROFESSIONAL MEETINGS

#### Financial Aid Meetings

Mother Bourret has attended two meetings recently on Financial Aid to students. The first she attended was the Association of Independent California Colleges and Universities' Admissions-Financial Aid Workshop held at Loyola in Los Angeles. Arthur Marmaduke, Executive Director of California State Scholarship and Loan Commission, delivered the keynote speech which traced the decline in scholarships awarded to private institutions (67% in 1961, and 57% last April); he has set a goal of 60% for the academic year 1968-1969.

On November 6, Mother Bourret attended the CEEB Counselor Workshop on Student Financial Aid held at San Diego State College. The purpose of this workshop was to explain financial aid policy and principles to highschool counsellors.

Association of Independent California Colleges and Universities

On Tuesday, November 17, 1967, Mother Morris, Mother de Leon, and Mother Furay attended the one-day meeting of the Association of Independent California Colleges and Universities in San Francisco, at the Hilton Inn near the San Francisco International Airport. The first presentation was "New Directions in State-Supported Student Assistance," an informative panel chaired by President Joseph B. Platt of Harvey Mudd College and consisting of Mr. Arthur S. Marmaduke, Executive Director of the State Scholarship and Loan Commission, Dr. Willard B. Spalding, Acting Director of the Coordinating Council for Higher Education, and Mr. James Gibson, Governor Reagan's Planning and Research Secretary in the area of higher education. Another session followed, during which Mr. Alfred W. Baxter of Baxter, McDonald & Company, Consultants in Planning and Management, explained the Joint Legislative Committee on Higher Education, as well as reported on its future plans; Mr. Baxter is directing a study being conducted by the Joint Committee. The afternoon portion of the meeting was a long business session, with reports from experts on the problems of the private sector of higher education relative to finances, legislation, federal relations, tax questions in gift solicitation, and the like.

October 26-28, 1967, Mother Guest and Mother Morris of CW and Dr. McGeever of CM attended the California Council on the Education of Teachers' meeting in Yosemite National Park.

The theme of the meeting was "Training Teachers for the "Disadvantaged,"" presented by several outstanding speakers who considered the contributions of anthropology, sociology, and criminology to such training. The highlight of the conference came at the business meeting on Saturday morning where the question was "The Future of CCET." Three position papers were presented by Mr. Larry Jones, Dr. Clarence Fielstra, and Dr. Hugh Black, who proposed remaining with the State Department of Education and continuing in this semi-dependent status, to become independent of the State Department of Education and make a study on ways and means of setting up an office on their own, and, finally, to change the direction of the Council from the State Department of Education to the joint desires of individual members as opposed to institutional members. The vote, advisory only, resulted as follows: 24 votes to return to the 1954 status, 8 votes to remain as is, and 91 votes to move toward independence. Thus, a study will be made by the newly-elected Board of Directors to investigate this last decision, and the final, definitive vote will be made at the spring meeting in April.

#### THE MERCY COLLEGE PROJECT

On November 7 Reverend Mother Danz, Mother Morris, Mother Furay, and Mother Carey drove to Los Angeles to investigate the nursing schools at UCLA and at Mt. St. Mary's. Miss O'Leary of UCLA explained that UCLA has two programs: the Baccalaureate Program and the Graduate Nursing Program, of which there are two kinds: the Master of Science Degree and the Master of Nursing Degree. The former is to prepare nurses for research, whereas the latter aims to prepare expert practical nurses and administrators of nursing. Sister Rebecca of Mt. St. Mary's says that their four-year program is very successful, but also very expensive."We returned to San Diego convinced in the good work such programs are effecting, but equally convinced that such programs require much money to launch and sustain," says Mother Morris. The final decision will come after a meeting with Sister Helene Marie of Mercy today at 2:00 p.m.
