AGENDA FOR FACULTY MEETING

As announced in the last Newsletter, the Faculty Meeting this month will be held as an experiment at 11:00 a.m. on October 8, 1968, in Room 14.

## Agenda:

1. Approval of minutes previously distributed.
2. Joint Statement on Rights & Freedoms of Students  
(from the minutes of the Faculty Meeting of March, 1968):  
"Dr. George moved that the administration appoint a committee to study the Joint Statement; motion carried. Mrs. Rothe moved that discussion of endorsement of the Joint Statement (or parts thereof) be at the November, 1968, faculty meeting, after having been presented to the faculty by the Committee at the October meeting; motion carried. There was also discussion about inviting CM to participate in our discussion."
3. Discussion: faculty office hours.

Proposition 6 (see attached Sample Resolution)
4. Recent discussions of formulating a policy on campus speakers.

2. October 17: Alumnae of Sacred Heart will have the Annual Fall Meeting, at which the grand opening of the Boutique de Noel will take place. Merchandise will be on display in the Italian parlor through December 20. Hours and days the Boutique are open are: Fridays from 11:30 a.m. - 1:30 p.m., and Sundays from 9:30 a.m. - 1:00 p.m. Funds are to go to the Student Lounge Remodeling Fund.
3. On December 12, 1968, the San Diego Ballet Co. will present a dress rehearsal performance of "Nutcracker Suite." Mrs. Michael Ibs Gonzales, with Mrs. James Phalen, will act as co-chairmen of this performance, the proceeds of which will go for the community development program of the University. Patrons tickets, \$5.00; student tickets, \$1.00.

4. As members of the faculty are aware, Admissions has been handled through the President's Office for many years, a very disadvantageous situation. Sister Annette Bourret has now been appointed Director of Admissions and Recruiting. Since so many of our admissions requests are contingent upon financial aid, it will facilitate the admissions procedure to have financial aid and admissions under the same direction.
5. The faculty will have already received the brief report of Father McGinley's synthesis of his study here at the University. The verbatim report will be distributed to the faculty as soon as Father McGinley sends it to us.

#### OFFICE OF THE ACADEMIC DEAN

1. Department Chairmen are requested to give to the Dean's Office a list of courses to be offered in their department for the spring semester, 1969, after consultation with Sister Furay on distribution of courses among members of the department. The list of courses should be typed as follows (Mrs. Jankowski will be happy to do this):
  - 1) Department title at the top
  - 2) Course numbers and descriptive titles
  - 3) Number of sections, if any
  - 4) Instructors for the courses
2. Summer Session courses:

At the same time as lists are compiled for second semester, department chairmen are asked to make a tentative listing of possible summer session offerings. This list, typed according to the same specifications as above, should be given to Sister Agnes Murphy, either through Inter-Office mail, or through the post office box she has arranged for in the post office downstairs. The summer session will be a joint one with the CM; with the lists you give her, and upon further consultation with you, Sister Murphy can so arrange that there are no duplications between the two colleges.
3. Faculty members who wish summer teaching appointments should discuss this with Sister Furay.
4. All of the above items (Nos. 1, 2, and 3) should be taken care of by the beginning of mid-terms.
5. There is a possibility of a post-session this summer, a three-week session following the main session (similar to that at San Diego State College). We would appreciate faculty viewpoint on the advisability of participating in such a post-session. This question has been put on the agenda of the faculty meeting.
6. Mid-term schedules will be given to the faculty and posted for the students on Monday.
7. The Woodrow Wilson Fellowship Foundation announces its "Identification Program of 1000 Designates for Graduate Study Awards Including 150 Woodrow Wilson Fellowships in 1969-1970 for First Year Graduate Study Leading to Careers in College Teaching." Faculty members who wish to nominate candidates from their department are asked to procure from Sister Furay one of the information forms; only students with a high GPA (3.5 and above) should be nominated. Nominations are due by October 20, 1968.

MEETINGSAmerican Association for State and Local History

Sister Mc Shane, Chairman of the History Department, was one of the few Californians present at the 28th Annual Meeting of the American Association for State and Local History, held in Washington, D.C., September 24-28.

The program included workshops and technical sessions on genealogy, history, manuscript preservation, etc. Part of the activities included a tour of the capitol by the Capitol Historical Society, a reception at the State Department where they saw the Department's antique collection, a special performance at the restored Ford Theatre, a reception at the White House, and a preview of the National Portrait Gallery which does not open until October 5.

Mr. W. Roy Holleman, Librarian, will address the librarians at the CURLD meeting on October 24 as representative of the Special Libraries Association. He will speak on Academic Status for Librarians.

PEQUOD

Dr. Lee Gerlach, Chairman of the CM English Department and moderator of "Pequod," College for Men literary magazine, invites both students and faculty members of CW to contribute poetry, articles, stories, etc. to this year's issue. Materials submitted are discussed at current staff meetings. Dr. Gerlach is particularly interested in securing good translations of well-known poems in other languages.

SAMPLE RESOLUTION

WHEREAS, the people of California have a vital and personal interest in the continued well-being and growth of higher education, and

WHEREAS, the retirement programs of teachers and administrative employees of California's colleges and universities historically have not been subjected to State premium taxes, and

WHEREAS, the broad effect of a recent California Supreme Court decision will result in a discriminatory tax on the retirement programs of independent colleges and universities while not affecting the retirement programs of State-supported institutions, and

WHEREAS, independent colleges and universities in California educate 25 percent of all college students at a savings to taxpayers of millions of dollars annually, and

WHEREAS, Proposition 6 will not increase taxes nor result in a reduction in State revenue, and

WHEREAS, Proposition 6 has the unanimous support of the State Legislature which placed this constitutional amendment on the ballot;

NOW, THEREFORE, be it resolved that \_\_\_\_\_ believes this proposal is in the best interest of the people of California and urges a "Yes" vote on Proposition 6 at the November 5 General Election.
