### Historical Note

Upon the merger of the College for Women and College for Men into the University of San Diego, the position of Provost was established. As the chief academic officer, the Provost served directly under the President on the organizational chart. Sister Sally Furay was appointed as the first Provost of the University of San Diego in May 1972. Furay remained Provost for 24 years, retiring in June 1996. Frank Lazarus then served as Provost until 2004 followed by Julie Sullivan. Andrew Allen began as Provost in 2013, and Gail Baker became Provost in 2017.

In addition to administering the academic functions of the University, the Office of the Provost oversees WASC reports and supports the University in moving towards the Strategic and Long Range plans.

Processing of this collection was conducted after various sets of records were transferred from the Office of the Provost to the Archives. No clear organization could be identified among the records as they arrived. Records within folders, however, often contain notations identifying topical organization and folder title guidance. Records, therefore, have been processed to reflect the topical organization presented. Series were identified where there was a clear set of like records. Records falling outside of these are located within the General Administrative records series.

For records acquired after 2016, original folder titles have been retained. Brackets "[ ]" are used where no folder title was given. Original folder titles are unknown for record acquired prior to 2016.

Additions to the collection will be intellectually integrated to fit within the above identified series, or added to new series as appropriate. In order to prevent unnecessary wear on records, and added processing time, additions will not be physically integrated within these series (unless otherwise noted). These additions will remain together in a new box.

## **Detailed Description of the Collection**

### **Series I: General Administrative records, 1960-2011**

Records in this series cover assorted topics of interest to the Office of the Provost. Among these are endowment records, Phi Beta Kappa information, information on Presidents of the University of San Diego, Kyoto Symposium information, and documents about the David May Collection. Background information and reports on various programs including the Community Outreach Partnership Center, Graduate and Continuing Education, Office of Sponsored Programs, and the Child Development Center are also included. Records also include correspondence and reports on the place and impact of the University of San Diego as a Catholic University.

### **Series II: Campus Diversity Programs, 1990-2005**

Records in this series document efforts to increase cultural diversity at the University of San Diego as well as planning and implementation of the James Irvine Foundation Grant.

### **Series III: College of Arts and Sciences, 1974-2012**

Records cover information on various programs offered within the College of Arts and Sciences with primary focus on the ABET (Accreditation Board for Engineering and Technology) Accreditation of the Electrical Engineering program. Planning and informational materials on the Center for Science and Technology, Center for Christian Spirituality, and Marine Studies, are among the programs covered within these records. ABET accreditation materials for the engineering program dated 2000-2004 are located within Series VI: School of Business.

### **Series IV: Faculty, 1973-1998**

Faculty records include Sabbatical requests and reports, and faculty research grants.

### **Series V: Government Relations, 1997-2007**

Records in this series consist of correspondence, research, proposals, and reports from the lobbying firms Capitol Associates and Cassidy and Associates.

**Series VI: Joan B. Kroc Institute for Peace and Justice (KIPJ), 1992-2007**

Records include founding documents, charter, event information, and correspondence surrounding the early years of the Joan B. Kroc Institute for Peace and Justice.

**Series VII: School of Business, 1979-2011**

Records document the Accreditation of the School of Business with some informational materials on the master's program. ABET Accreditation records 2000-2004 are also included.

ABET accreditation records dated 1991 to 1997 are located in Series III: College of Arts and Sciences.

**Series VIII: School of Education, 1976-2013**

School of Education records pertain to teacher credentialing, implementation of a joint doctoral program, records on Marriage, Family, and Child Counseling, as well as information on the School of Leadership and Education Sciences (SOLES).

**Series IX: School of Law, 1968-2009**

Records include documentation of various programs offered by the School of Law including Legal Clinics, the Lawyer's Assistant Program, Center for Public Interest Law, and the Patient Advocacy Program. Accreditation records for the American Bar Association are also included.

**Series X: School of Nursing, 1973-2010**

Records include accreditation and enrollment information, historical information on the School of Nursing, buildings, and implementation of the PhD program.

**Series XI: Strategic Long Range Plan, 1971-2005**

Records in this series consist of planning and reporting information for the University of San Diego Strategic Long Range Plans.

**Series XII: Western Association of Schools and Colleges (WASC), 1953-2004 12 linear feet**

Records in this series contain planning materials, committee records, visitation information, drafts and final submission materials gathered in preparation for Accreditation with the Western College Association and Western Association of Schools and Colleges. Records are both foldered in boxes as well as stored in binders. Final accreditation reports have also been cataloged in the Copley Library catalog records.
