### OFFICE OF THE PRESIDENT

#### Specific Objectives of USD: 1974-1975

Members of the faculty and administration who were here last year will remember that, at the end of September, I held a University-wide meeting to discuss the Philosophy, Goals, and Objectives of the University of San Diego. Papers distributed at that meeting listed, along with the Philosophy and Goals of USD, about twenty Specific Objectives to be accomplished during the year 1973-1974. Before too long, I will give you a report on our track record in achieving those objectives set out on a University-wide basis.

Together with the University Cabinet, I am currently in the process of developing the University's Specific Objectives for 1974-1975. I invite anyone who desires to do so to contribute to that process. Should you wish to offer suggestions for Specific Objectives for the University of San Diego for 1974-1975, please submit them in writing to me sometime this week, or at least by Monday morning, September 23, 1974. I hope to compile all the suggestions and work out the Specific Objectives with the University Cabinet during the week of September 23.

### USD Veterans Representative:

With the commencement of the 1974-1975 academic year, USD entered into an agreement with the Veterans Administration for a full-time Veterans Representative to work with our Veteran students, at government expense, under a new Veterans Administration program. The Vet Rep for our campus is Mr. Amos Martinez.

Mr. Martinez received his Bachelor's degree from the University of New Mexico and while there completed the NROTC program and entered the Navy as an Ensign. He attained the rank of Lieutenant before being released from active duty in April, 1973. Mr. Martinez' graduate studies in Guidance and Counseling were taken at USIU from which he received his Master's Degree in 1974.

Among the services the Vet Rep offers our Veteran students are assistance in matters relating to application of Veteran benefits, supervision of delivery of advance payment checks and the resolution of problems related to payments and benefits. Mr. Martinez will also provide counseling for disabled veterans and assist them in whatever way he can. The coordination of VA matters with on-campus veterans groups by providing briefings in salient subjects will be a function of his office. In addition the Vet Rep will maintain liaison with school officials through regular contact and discussion of VA educational assistance and provide a referral service to agencies providing assistance in areas of housing, employment, health, recreation, vocational and technical training and financial assistance.

Those who might wish additional information can contact Dr. Patricia Watson, who has handled the arrangements with the Veterans Administration. Anyone wishing to meet with Mr. Martinez will find him located in the ASB Veterans Office near the Student Union in Serra Hall. His telephone is 299-6541.

### Nursing Office:

Several have asked how to get in contact with the new Hahn School of Nursing and Allied Health Science. As most of you are aware, the contact point for the past year and a half of planning has been my office. The new contact point is in Founders Hall, where the Secretary to the School of Nursing is now in Room 124A. Dean Palmer's office, when she arrives, is next to the Secretary's (Ms. Dedra Elliott) in Room 124B. Until Dr. Palmer arrives, please contact one of the nursing faculty (Claire Gulino and Frances Geddo) at extension 341. Their office is Room 123 in Founders Hall. All of these offices are just down the corridor from the Registrar's Office.

### Registration Meeting:

On Thursday, September 12, a meeting was held by way of a sort of "post-mortem" on the Fall, 1974 registration. Discussion centered on various phases of the registration procedure - what went well and what went badly - with an eye to improvement in the future. It was the consensus of the group that one person is needed in overall charge of registration in the undergraduate and graduate areas, exclusive of the School of Law.

Hence, I have asked Dr. Patricia Watson, because of her position as Director of Academic Services, to be the person in overall charge of Registration. Those who wish to offer their ideas and/or suggestions could contact Dr. Watson.
