Open Hearing on Budget:

The University Budget Committee, chaired by Mr. Jack Boyce, Vice President for Financial Affairs, and Sister Sally Furay, Vice President and Provost, will hold an open hearing on Tuesday, October 24, 1978 from 2:30 - 4:00 p. m. in Salomon Hall, DeSales. The purpose of the meeting is to summarize the work the Budget Committee will be doing over the next couple of weeks, and to seek additional input prior to forwarding Committee recommendations to the University Cabinet, which in turn forwards them to the Finance Committee of the Board of Trustees before the full Board acts at its meeting of November 5, 1978.

This phase of the budget process involves the setting of priorities for utilization of new income for the year 1979-1980. The University needs this information for the November meeting of the Trustees primarily because of that segment of the budget data involving new and replacement personnel, for whom recruitment must begin at an early date. Hence, the current phase involves general budget outlines rather than specific line items of individual budgets.

Members of this year's Budget Committee, besides Vice Presidents Boyce and Furay, are: Dr. Gilbert Brown, Dean Burns and Professor Cook from the School of Business, Dean Weckstein and Professor Alexander from the School of Law, Dean Palmer and Professor Breen from the School of Nursing, Dean Elliott and

Professor Nelson from the School of Education, Dean Pusateri and Professor Oddo from the College of Arts and Sciences, Dean Brandes, Dean Burke, Dr. Watson, Mrs. Holleman, Mr. Weinsheim, Mr. Zeterberg, Mr. Snell, Ms. Scheumack, Mr. Mark Norych from the Student Bar Association, Mr. Mike Taylor from the Associated Students, and a graduate student to be appointed.

Freshman Class Profile:

The Admissions Office has completed its annual profile of the Class of 1982, which is appended to these Newsnotes. You will note that the statistical information concerns 583 entering freshmen, which is not the same as the total headcount of freshmen (656) reported in the last Newsnotes. The profile appended here includes only first-time freshmen entering in September, 1978, while the enrollment chart headcount includes transfer freshmen and those who may have come to USD last February and are still classified as freshmen.

VARIA

The National Science Foundation has awarded the University of San Diego a \$12,300 grant to assist in the improvement of the quality of undergraduate science instruction through the acquisition of instructional scientific equipment. The project is under the direction of Dr. Patricia Traylor, Department of Physical Science and Mathematics.

On Monday, October 2 Dean Weckstein, School of Law, was a guest on KPBS radio from 8 - 9 p. m. with Diane Brown. The topic of discussion was "Legal Education."

On October 4, Father William Shipley, Religious Studies Department, spoke to the La Jolla Lions Club on the subject of the morality of capital punishment.

Professor Dennis Clausen, Director of the Writing Program, recently spoke to the faculty and administration of University High School. The subject was "The Teaching of Writing in the High Schools." Together with Carol Hammond, head of the English Department at University High, Dr. Clausen is helping that school design a writing program that is in part modelled after USD's Writing Program.

Professors Michael Soroka and Eugene Labovitz attended the meetings of the American Sociological Association in San Francisco, September 4-6, 1978.

Dr. Doris Durrell attended the meetings of the American Psychological Association in Toronto, Canada August 28 - September 1, 1978.

Dr. Patricia Feulner attended the Washington Center for Learning Alternatives Symposium on Aging in Washington, D. C. in June, 1978. Her manuscript "Women in Professions: A Social-Psychological Study" was accepted for publication by R & E Research Associates.

Dr. Angelo Oróna has returned from a summer of anthropological field study among the coastal-rural fishermen of Marguerita Island in Venezuela.

Dr. Daniel Moriarty has recently been elected a member of the Division of Physiological and Comparative Psychology of the American Psychological Association.
