CONGRATULATIONS:

Congratulations to President Hughes on his election to a two-year term as President of AICCU (Association of Independent California Colleges and Universities). Dr. Hughes replaces Robert Rosenzweig of Stanford University on July 1, 1982. The AICCU handles relations with Sacramento, as well as other matters, for the entire independent sector of higher education in California.

COMMENCEMENT SPEAKERS:

Bernardo Sepulveda, Ambassador of Mexico to the United States, will address the Undergraduate/Graduate Commencement on May 23. Prior to his appointment as Ambassador, Mr. Sepulveda was Secretary of International Affairs of the Institutional Revolutionary Party. He has also been the Advisor on International Affairs to Mr. Miguel de la Madrid Hurtado, PRI candidate for the Presidency of Mexico.

In 1981, Mr. Sepulveda was a member of the Mexican delegation to the International Meeting on Cooperation and Development of Heads of States and Governments. He has held positions of Advisor on International Affairs to the Secretary of Planning and Budget, Assistant Secretary of International Affairs of the Ministry of the Treasury, and coordinator of a program on foreign investment in Mexico for the Secretary of the Treasury, among others.

Sepulveda has published widely in areas of Mexican relations and is currently a professor of International Law and of International Organizations at El Colegio de Mexico. He received a law degree (Magna Cum Laude) from the National University of Mexico in 1964, and a Master's Degree in International Law from Cambridge University (United Kingdom) in 1966.

The Law Commencement speaker this year is Professor Robert B. McKay. He has served as Dean of New York University's Law School, is well-known in the legal community, and for a period of time ran a legal institute in Aspen, Colorado. He holds a J.D. from Yale, an LL.D. from Emory, and a D.H.L. from Mount Saint Mary College.

McKay has been an attorney with the U.S. Department of Justice and a faculty member at Emory and New York universities. Included among his

numerous honors are the Edward R. Finch Law Day Prize awarded by the American Bar Association, the Torch of Learning Award of the American Friends of The Hebrew University, the Arthur T. Vanderbilt Medal of New York University School of Law, and the Stanley M. Isaacs Human Relations Award of the American Jewish Committee, New York City Chapter.

Law School Clinic Professors Michael Evans and Steven Hartwell ran two legs for the San Diego Track Club in setting an American record in the Masters' One Hundred Mile Relay on May 9th at Grossmont College. With each of the one hundred runners carrying the baton one mile, the local Track Club covered the one hundred miles in eight hours, forty minutes, breaking the American record by four minutes and missing the world record held by a London team by only seven minutes.

Mr. David Tiedemann, Director of the Media Center, served a a Convention Evaluator at the 1982 Convention of the Association for Educational Communications and Technology in Dallas on May 2-7, 1982. He obtained current information and literature for techniques and products in the following areas: off-air videorecording; language laboratory design; videotext; videodisc; CAI; microcomputer based music instruction; video in special education; and computer assisted television instruction.
