#### Undergraduate Majors at USD:

The Registrar's Office, at the request of my office, has provided a listing of the number of students who have declared a major in the various academic disciplines. This information has been provided each fall semester for the past several years, and for the spring semester as well a few times. It seems useful to continue supplying this data for spring as well as fall. Data on declaration of majors is in constant flux as students change their majors or move from "undeclared" status to a declared major. The data should, therefore, be considered only an approximation. Data is based on official declaration of major on proper forms in the Registrar's Office; informal arrangements with faculty or department chairs do not constitute a declaration of major by the student. Because changes of major are rare among seniors, less common among juniors, and quite usual among sophomores and freshmen, it is relevant to know the level of students listed. Hence, information on undergraduate majors has been subdivided into upper division and lower division students.

Professor Donald Weckstein, School of Law, has been appointed to the San Diego County Bar Association Committees on Legal Ethics and on Arbitration.

On February 11, 1983, he made a presentation to the American Arbitration Association program on Fundamentals of Grievance Arbitration, in San Diego. On February 26, he was a participant in a mock mediation of a construction dispute (along with Louis Welsh) presented at the American Bar Association program on Alternative Dispute Settlement, in Coronado.

Also in February, he participated in American Bar Association meetings of 1) Administrative Law Section and House of Delegates (which considered the controversial new rules on professional ethics) in New Orleans; and 2) Labor Law Section where he presented a report on Interest Arbitration, in Scottsdale, Arizona.

On March 24, Dr. Michael Wagner, Philosophy Department, read a paper entitled "Metaphysics and Values in Plotinus" at the American Philosophical Association-Pacific Division meetings in Berkeley, California. He also chaired the session.

Dr. Louis Burnett of the Biology Department presented two papers to the Society for Experimental Biology which met in Strasbourg, France on March 22-24, 1983. The title of the papers were "Carbon dioxide movement across artificially perfused crab gills" for which Dr. Burnett was a single author and "Branchial CO<sub>2</sub> elimination in the crab <u>Cancer productus</u>" coauthored with Dr. B.R. McMahon, University of Calgary and Dr. P.L. deFur, George Mason University.

Dr. Burnett also presented a seminar on March 29 to the Zoology Department of the University of Massachusetts at Amherst entitled "Role of the enzyme carbonic anhydrase in excretion of carbon dioxide across crab gills."

Dr. Dennis Rohatyn's paper entitled "Why 'International Relations' Cannot Be True" has been published in <u>Poznan Studies in the Philosophy of the Sciences</u>

and the Humanities, Vol. I, No. 4 (1975), 68-72. There had been an eight-year delay in the activities of this journal, owing to the actions of the Polish government.

Dr. Alana Cordy-Collins, Anthropology Department, was chairperson of a symposium for the Society for California Archaeology on March 24, 1983. The topic was Papers in California Archaeology. She presented a paper entitled "The Cerro Sechin Massacre: Did It Happen?" at the Southwestern Anthropological Association symposium on World Views in the Americas, March 25, 1983. During Easter Week, Dr. Cordy-Collins was in Veracruz, Mexico studying archaeological sites and museum collections.

As president of the Greater San Luis Rey Area Planning Council, Dr. Patricia Lowry of the School of Education has chaired the monthly meetings of the Council which has focused this spring on a Salute to the Communities of Oceanside/Carlsbad; Vista/Bonsall/San Luis Rey; and a Salute to San Marcos and Escondido planned for April 28. The GSLR Council, established in 1959, brings together business and professional leaders who voluntarily provide an open forum for discussion of vital issues in the North County communities.
