# LAW AND MARRIAGE Go together like a Horse and Carriage?

However, I know classmates who have even more demands on their time. In addition to all the standard law school obligations, they also planned (or are planning) a wedding.

These people attend class, have fulfilling internships, and sometime, between all the school and career demands, find a way to plan beautiful weddings. They do it with efficiency, grace, and poise. I can't help but marvel at how they keep it all under control. To reveal the mystery behind being a put-together law student and a dutifully betrothed, I put another demand on their time and asked them to share their advice.

It is possible to plan a wedding during law school without destroying your GPA. As 3L student Tania Bakar, who is getting married this March put it, "It is all about time management." You need to determine the amount of time between now and your wedding day and allocate accordingly. Motions Editor, Nico Weiss who proposed to 3L student Annie Su last summer, suggests treating it as you would any other spare time from law school. "For me," he said, "it means a little bit less videogames and Netflix...but that's okay."

We all have lives outside of law school. Wedding planning while in law school just means reprioritizing those things or creating a time line that will work with your school demands. Annie Su and 3L student, Samantha Yarman-Patterson (whose wedding will be May 2014) each said their long engagement has helped them stay focused on their studies. "My fiancé and I have a 15 month engagement," Samantha explained. "It may sound long, but really goes by quickly." Longer engagements have other perks, like being able to utilize winter and summer breaks to take care of a lot of wedding details at once. Emily Little, who was married just after her 1L year, says that would be her number one tip to anyone planning a wedding during law school. "Do as much work as you can over school breaks and then do your best to relegate all wedding planning to one day or night per week."

By using weekends, breaks, and sticking to a schedule, you can plan the wedding a little bit at time without becoming overly burdened.

Scheduling your wedding planning for breaks and weekends eliminates the distractions while you are trying to study, but also keeps you on track for the big day. However, one thing that every student interviewed agreed on, was that you should avoid any wedding related planning or activities during finals. Your final exams should take priority over your wedding plans and because your fiancé (hopefully) knows how important law school is, they should understand the need to set wedding matters aside for a few weeks. All the interviewees also agreed that you should not rearrange your class schedule to have more time for wedding matters. Kristi Hubbard, who was married during her 2L summer, said, "You don't want to lighten your load so much that you will end up burdening your other semesters (particularly your last one)."

"I just made sure to take classes I was really interested in so that studying for them wouldn't be so hard," said Kristi If you have accumulated extra units from summer school and can afford a lighter class load the semester before your wedding, you will certainly utilize and enjoy the extra time, but it isn't necessary. Most interviewees said that if you follow the advice of planning early and scheduling a day or evening per week to manage wedding details you won't feel the need to take a lighter class load.

While wedding planning can be distracting, most law students are focused enough on their studies and graduating on time that they find other ways to manage the demands.







# FRADULENT LOVE How Online Dating Sites Keep It Real

She was perfect—tall, dark, athletic. She saw 52 sunsets a year, rode a bike with speakers. Her favorite bands were Talking Heads and Diggs Duke. Her name sounded like poetry.

"Celestine."

Jack fell in love with Celestine the first time he saw her. It was two months after the combustion of an 8-year relationship. Now 31, Jack had forgotten how to meet women. He attended the wedding of a fraternity brother in Cleveland. Turns out, Casey met Jeannine on a dating website. Jack started a profile and found Celestine.

They exchanged emails, text messages; even phone calls. "I've never felt so close to someone," she said. Jack agreed.

But Celestine's mother was sick. Pancreatic cancer. Her condition got worse by the day. Mom had no insurance. She couldn't afford her medication. Jack sent her \$5,000 via Western Union.

The next day, Celestine's profile vanished. Emails were rejected. Phone calls went unanswered.<sup>1</sup>

Online dating sites provide unique opportunities for romance. Before the first date, you know who is a militant vegan, a mother of two, a cat person. And for every swindle and con, there are ten successful relationships. In the past year alone, the author has been invited to four weddings that otherwise never would have transpired.

Yet there is this looming danger, a fear that you will expose your essence in digital form and have your money sweet-talked away by a girl in a telemarketing assembly line. So what do these websites do to prevent well-meaning introverts from losing their shirts without any of the benefits?

Both eHarmony and Match, the two largest dating sites in the U.S., employ full-time

fraud-prevention teams. Using a combination of high technology and good-old-fashioned intuition, the team discovers and disables accounts. In addition, they conduct background checks on new members to catch the sexual deviants and grifters.

According to an industry insider, onlinedating sites typically use three methods to detect scammers. First, they employ full-time teams of trained professionals scour profiles for red flags. If Jane Scott's image is strangely similar to a recent *Sports Illustrated* swimsuit spread, they may disable the profile. As a second layer, sites rely on users to flag or report suspicious conduct. Lastly, many sites use NSA-style technology to scan messages for buzzwords. Fortunately, there are very few legitimate reasons to "wire money" in that context.

Yet according to the Federal Bureau of Investigation, thousands of complaints are filed each year alleging fraud on online dating sites. A study published in October 2012 in *Glamour* estimated that one in ten profiles were fraudulent. The study was published just one month after a U.S. District Court judge Sam Lindsay dismissed a class-action suit against Match.com alleging that over *half* of the profiles were fraudulent.



Many users have eschewed the big dating networks for sites with more exclusivity. Beri Meric, co-founder of IvyDate.com and DateHarvardsq.com analogized it to the real world. "[P]eople are looking to go to the right neighborhood to meet the right people." On Meric's sites, a full-time membership committee reviews every profile and photo submitted, looking for red flags like celebrity photos or poor translation.

And who are the victims? Do they also help exiled Nigerian princes recover their fortunes? Unfortunately, the victims are normal people who succumb to what psychologists refer to as the "halo effect." They find something they like about someone, and overlook all of the shortcomings. Celestine was interesting and beautiful.

Yet, there is still another side to this drama. Thousands of people around the world, celebrities and soldiers alike, have their pictures, their stories, their identities stolen to create narratives. Recently, a "model" in Miami filed a suit against Match seeking \$1.5 billion in compensatory and punitive damages. Although there is no chance she will recover that amount, it does highlight the very real, perceptible damage that can occur when someone's identity is used as a tool for fraud.<sup>2</sup>

For many in the legal community, online dating provides the only realistic way to balance a demanding work schedule and the challenges of intimacy. As was recounted earlier, the author has been invited to four Match weddings in the past year alone. There were no Russian accents, and no dying mothers. Just remember, until you meet that special someone in person, do not pay for her mother's chemo.

A: I would say funny. Comedy.




