Tuition Remission:

Last July, at my request, Sister Furay sent to Vice President Boyce and me a Memorandum summarizing information received by USD from Washington, D.C. associations about changes in the tax treatment of tuition remission plans at colleges and universities. I subsequently forwarded her Memorandum to USD faculty and staff, for their information.

Financial Aid Trends:

For the information of members of the academic community, I am attaching the following charts to these <u>Newsnotes</u>: 1) Undergraduate-Graduate Financial Aid trends from 1975-76 to the present and 2) Law School Financial Aid Trends from 1976-77 to the present.

Budget Summary: Expenditures:

As usual at this time, we are publishing the official summary of the budgeted expenditures at the University of San Diego for the current fiscal year (September 1, 1985-August 31, 1986). The 1985-1986 budget summary is attached.

For your information and interest, most of the budgeted operating revenues which balance the \$46.6 million in expenditures come from three sources:

Tuition and Fees:	72.1%	(\$33,617,036)
Room and Board:	11.3%	(5,259,306)
Other Auxiliary Enterprises:	8.7%	(4,076,913)
(such as Bookstore, Special Events,		
summer camps, food service to		
outside groups, etc.)		

The other 7.9% of operating revenues come from such sources as federal workstudy funds; private gifts, grants, contracts; Graduate Career programs; outside-funded centers; interest and dividend revenue; etc.

Faculty Research Fund Report:

A total of \$110,000 was expended for 1984-1985 to support faculty research projects. Below are summarized the projects for which the Provost's Office received reports from the Deans.

College of Arts and Sciences

Dr. Cynthia Caywood, English, traveled to Wake Forest University, in Winston-Salem North Carolina, where she worked on her anthology of essays, <u>Teaching Writing:</u> <u>Pedagogy and Questions of Equity</u>, with her collaborator, Dr. Gillian Overing. The manuscript has been sent to SUNY-Albany Press.

Dr. Alana Cordy-Collins, Anthropology, conducted an archaeological field research at Pacatnamu, Peru, beginning June 9, 1985. She is now in the process of completing an excavation report which will be published in <u>The Pacatnamu Papers</u> by the UCLA Museum of Cultural History in Spring, 1986.

Dr. Joanne Dempsey, English, updated the bibliography of her doctoral dissertation, "<u>Paradise Regained</u>: The Aesthetic of Obedience" (Harvard University, 1983). She also completed bibliographies on Spenser, Narrative, and Narrative Motifs, and on Literary Theory (contemporary) and Literary History.

Dr. Pat Drinan, Political Science, did research in the USSR in July, 1985, to collect information on party organizational efforts in the countryside during 1924-1926, which will be analyzed in a paper to be presented at the Western Social Science Association early next year. He also used this opportunity to arrange interviews with senior Soviet researchers at the USA-Canada Institute in Moscow on such topics as U.S.-Soviet arms control negotiations, the Strategic Defense Initiative and bureaucratic difficulties associated with synchronizing strategic forces planning for the 1990's. These interviews will be used in a manuscript on U.S.-Soviet planning cycles which is in the early stages of preparation.

Dr. Hugh Ellis, Biology, used his grant to study the field of energetics of certain coastal seabirds, namely, the California Gull and Eared Grebes. The grant also enabled him to purchase equipment and supplies needed for this study.

Dr. Iris Engstrand, History, did research on California under Spain and Mexico which resulted in a chapter for a book to be published by the Greenwood Press entitled <u>A Research Guide to California History</u>. In addition, she was able to write a short work on "Junipero Serra: Founding Father of San Diego" for a book edited by Msgr. Francis J. Weber, entitled <u>Some Reminiscences about Fray Junipero</u> <u>Serra</u>. Her article on "The Enlightenment in Spain" was published in <u>The Americas</u> in April, 1985, and one on "California Ranchos: Their Hispanic Heritage" will be published in the Southern California Quarterly in an upcoming issue.

Dr. Gerald Estberg, Physics, received a mini-grant to provide a computer and other support for a student who did a research project under his supervision; the student's project was to complete a spectral analysis of recorded rainfall record for L.A. and other west coast stations. Dr. Lee Gerlach, English, completed a book of poems titled <u>The White Treaties</u>. He also worked on creating a different kind of poem based upon an Indo-Persian form of ancient lineage: the Ghazal. He is tentatively projecting 100 poems in a set, which he calls "Wayland: Wandering."

Dr. Janice Koop, Mathematics, completed research data on "High School Mathematics Participation and Success in Mathematics at USD" which information will be used for future departmental and admission decisions.

Dr. Eugene Labovitz, Sociology, completed his book <u>An Introduction to Social</u> <u>Statistics</u>. In addition, he attended an American Sociological Association workshop at the University of Minnisota on computer based instruction which will help him develop a tutorial program for the microcomputer which may be used along with the above textbook.

Dr. Gary Macy, Religious Studies, completed his book <u>The Banquet's Wisdom:</u> <u>Christian Thought on the Eucharist from the Beginning Through the Reformation</u>, and has received a contract for the book from the Paulist Press in New York. He is beginning a companion volume to his book, <u>Theologies of the Eucharist in</u> <u>the Early Scholastic Period</u>, and did research in England at the University of Cambridge, besides Rome and Paris.

Dr. Mitchell Malachowski, Chemistry, used his mini-grant to purchase chemicals in the research of his project on the "Synthesis and Study of Macrocyclic Receptors." His initial results on this project allowed him to obtain an American Chemical Society Project SEED grant which paid for a high school student to work with him. The project has been extremely successful and he is anticipating publishing the work sometime this Fall or Winter. In addition, he's presently in the process of incorporating the above results into a more comprehensive research proposal which he will submit to the National Science Foundation for funding.

Dr. Virginia Muller, Political Science, collected extensive materials on the "conversations" between Martin Buber and Gandhi, which she is compiling and is confident will lead to eventual publication. She also prepared a paper on Mary Wollstonecraft and her relevance in the feminist tradition; this was presented at the Western Social Science Association meeting in April.

Dr. Ben Nyce, English, traveled to India to do research on the films of Satyajit Ray, the great Bengali filmmaker. He tape-recorded his interview with Ray, his film crew and several of his actors which he will use in his book-length study of Ray's films. As a result of his work in India, he has two-thirds of his manuscript completed.

Dr. James Otte, History, used his mini-grant to pay a typist to make the necessary revisions and additions to his manuscript: "Alfred of Sareshel's Commentary on the Metheora of Aristotle", (a critical Latin edition of a 12th Century commentator). This manuscript has been accepted for publication at E.J. Brill, Leiden, the Netherlands. It will appear in a series entitled: <u>Studien and Texte in der</u> <u>Geistesgeschichte des Mittelalters</u>, St. Thomas Institute, Universitat Koln, W. Germany. Dr. Richard Philips, Environmental Studies, hired an assistant with his grant to complete the compilation and statistical analysis of data concerning the coastal processes on the east coast (South China Sea coast) of peninsular Malaysia, and to redraft illustrations for publication. As a result of this, there will be two publications: Long-shore Transport of Sediment During August and September on the Terengganu (Malaysia) Coast; Pertanika (Bull. of the Agricultural University of Malaysia), in Press; and The Black Sands of Lankawi Island, the Malayan Naturalist supplement to the Malayan Nature Journal of the Malayan Nature Society, in Press.

Dr. Mary Quinn, English, completed three projects: 1) A lengthy review of Shelley's Adonais: A Critical Edition by Joseph Anthony Knerr; the review is completed and forthcoming in <u>The Wordsworth Circle</u>, Summer 1985; 2) The revision of a note, "Leigh Hunt's Presentation Copy of Shelley's <u>Alastor</u> Volume,"; the note is completed and forthcoming in the <u>Keats-Shelley Journal</u>, 1986; and 3) A review of Neil Fraistat's <u>The Poem and the Book</u>, Interpreting Romantic Poetry; the note is forthcoming in the 1986 issue of K-S Journal.

Dr. Michael Ross, Political Science, completed work on his book <u>Politics</u>, <u>Govern-ment and Policy in American States and Localities</u>: <u>Change and Reform</u>. The manuscript has been sent by the publisher, Prentice-Hall, to faculty reviewers for editorial comment.

Dr. John Schindler, Chemistry, used his grant to develop a Physical Chemistry Laboratory Course, which involved much research of other curricula from various universities before one could be developed. It is now completed and computer programs were written for data analysis in the various experiments.

Dr. Steven Schoenherr, History, completed a computerized bibliography search of citations compiled by <u>American: History and Life and Dissertation Abstracts</u> which will help him in writing a book-length manuscript on the use of mass media by Franklin Roosevelt and his administration during the 1930's.

Sister Pat Shaffer, Chemistry, researched the regulation of two enzymes in nonpurified preparations to study the role of ascorbic acid (Vitamin C) as a chelator of iron ion. She plans to submit these results as an Abstract at the June 8-12 1986 Meeting of the American Association of Biological Chemists and as a paper to the journal Molecular and General Genetics.

Dr. Florence Spuehler, Fine Arts, revised a multi-media program integrating Art, Music and Literature of the Modern Art Period by completing a new introduction involving 20 new slides and theme music; update of music with the purchase of replacement records; revised the continuity with musical and visual additions; taped a master reel to reel tape and duplicated slides to complete three full programs, one for her files, one to be left for university use and one for future grant proposals.

Dr. Bart Thurber, English, used his grant for transportation expenses incurred in his anthology of essays, <u>Teaching Writing</u>. He also worked on his novel, <u>Desert</u> <u>Sea</u>.

Dr. Patricia Traylor, Chemistry, used her grant money on items required in the attempted conversion of neocuproine to the monoaldehyde as well as for conducting various steps in the synthetic schemes.

School of Business

Dr. Andy Allen, Business, completed a paper on <u>The Welfare Implications of</u> Stabilizing Interest Rates Under the Real-Bills Doctrine.

Dr. Joan Anderson, Business, completed two papers: 1) <u>Defense Spending and Inflation:</u> <u>A Comment</u>, co-authored with Leslie Levey (an MBA student), presently under review by a journal; 2) <u>Size Efficiency and Profitability: Empirical Evidence from Mexican</u> <u>Assembly Plants</u>, which was presented to the Pacific Coast Council on Latin American Studies meeting in Las Vegas, October 17-20, 1985, and also was submitted for review by a journal. She also made significant progress on analyzing attitudinal difference toward work and productivity between California workers, Mexican workers working in California and Mexican workers working in Mexico; these have been computerized. Also, she conducted a survey of USD students on social justice attitudes which was a joint project with Dr. George Bryjak, Sociology. They are in the process of doing an analysis on this data.

Dr. Betty Arnold, Business, conducted an Estate Planning survey of 262 professors of business, which results she planned to use to persuade a publisher to either publish her estate planning text or the text of some other author. As of June 4, 1985 she obtained a text book contract with Addison Wesley Publishing Company.

Dr. David Burt conducted a study of the Role of Personal Characteristics and Work Training Experiences in Successful Purchasing Design Engineering Interfaces which results will be presented at the National Association of Purchasing Management Research Symposium at the Arizona State University in March, 1986. As more data becomes available, an article will be prepared for the <u>Journal of Marketing</u> and a second one for the Journal of Purchasing Materials Management.

Ms. Denise Dimon, Business, conducted research on the Effects of U.S. Immigration Law on Manpower Characteristics of Immigrants.

Dr. Gregory M. Gazda, Business, developed a series of experimental exercises as part of a readings and case book for use in Principles of Real Estate courses.

Dr. Don Helmich, Business, submitted an article of a conceptual series of Propositions developed from a model paradigm based on prior investigations in the field of executive succession planning to the <u>Academy of Management Review</u>. He also developed a paper, with the senior Executive Planning Officer of General Dynamics, for the National Academy of Management Proceedings.

Dr. Johanna Hunsaker, Business, completed her research on Fear of Success which was incorporated into the book <u>Strategies and Skills for Managerial Women</u>, to be published by Southwestern Publishing Company, 1986; submitted a paper entitled, "A Critical Analysis of the Fear of Success Concept" to California Psychological Association, February 27-29, 1986, San Francisco, California; and a paper, <u>A Contingency Approach to the Fear of Success Construct</u> to Western Academy of Management, March 20-22, 1986, Reno, Nevada. She plans to rewrite these conference papers and submit them for publication. Dr. Phillip Hunsaker, Business, conducted research on the Managerial Stress in the Police Service which resulted in its being submitted to the <u>Journal of</u> Occupational Medicine.

Dr. Cindy Pavett, Business, completed an empirical investigation into the intervening variables that influence performance, attendance and a host of additional variables, in the <u>Organizational Benefits of Employee Physical Fitness</u>. She also revised six manuscripts already in progress, two of which have been re-submitted to journals, and one which has been accepted for the Western Academy of Management meeting.

Dr. Gary Whitney, Business, wrote a student manual and instructor's manual to accompany Cartels and Cutthroats, a computer simulation.

Dr. Dennis Zocco, Business, made significant progress toward the completion of the <u>Investor</u> Textbook/Educational Software Product which will be marketed by South-Western Publishing Company beginning in the 1986-87 academic year.

School of Education

Dr. William Foster, Education, conducted research in the area of educational administration and prepared for publication a manuscript on educational administration. The manuscript has been submitted and is currently under review at Prometheus Press. He hopes to have the book edited for publication in the Spring of 1986, with an expected release for Fall, 1986.

Dr. Jack Morrison, Education, completed research on <u>Adolescent Insomnia</u>; presented a paper to the California Personnel and Guidance Association, spoke at the La Jolla Country Club, Cloisters, and USD. He is preparing articles for the <u>School</u> <u>Counselor Journal</u> and <u>Journal of Adolescence</u> and also did some consulting at Stanford University. He collected various data from University of San Diego High School, which resulted in the draft of an article co-authored with Dr. Kujawa on Adolescent Insomnia. His article "Causes and Treatment of Insomnia Among Adolescents" was in the April issue of Journal of <u>School Health</u>.

Dr. Joseph Rost, Education, worked on a new book which will detail an emerging theory integrating leadership and policy-making models and perspectives; wrote a 25-page paper for AERA on the politics involved in developing the model curriculum standards and the program review document for the State of California; and lastly, began rewriting a 30-page chapter on the nature of politics which he had originally written some time ago.

Dr. Jan Writer, Education, conducted a study of the Impact of the Community-Based Training Program on Project Participants, their USD Employers and the Peer Tutors Who Work With Them. A 48-page paper has been written on the project and submitted to the California State Department of Education. Data is being prepared for analysis on the assessments made of the pre- and post-test of project participants' performance. A survey of USD's employers' (and potential employers') attitudes toward workers who experience severe disabilitites was drafted. She also wrote a 212-page special project grant for the Division of Special Education; and re-organized and developed a paper on prelinguistic communication skills development into a book chapter for Paul Brookes, Publishers.

School of Nursing

Dr. Evelyn Anderson studied patients who had been treated with progestins along with estrogen replacement therapy to determine whether it affected their decision to continue the use of hormone replacement therapy.

Dr. Regina Aune did research to determine the career anchors of men in professional nursing and to ascertain if the service anchor, previously identified in research with women in the profession, would be identified within the sample of men studied.

Dr. Perri Bomar did research to determine the coping strategies, hassles, and uplifts of R.N.'s enrolled in a bachelor's degree program in nursing.

Dr. Janet Harrison developed computerized teaching illustrations and programs for classroom use in demonstrating computer applications in nursing management.

Dr. Mary Ann Hautman developed a paper for presentation at the 18th Congress of the International Council of Nurses in Tel Aviv, Israel. The paper dealt with the changing philosophical approach to health care in countries throughout the world, though primarily in technologically advanced societies.

Dr. Patricia Roth explored health perceptions of older women and determined if other variables significantly effect their perception of their own health. This study served as a basis for a presentation in Family Health Nursing III, a presentation to the University of the Third Age, and in guiding a student project.

Ms. Sharon Burns Stewart researched and subsequently wrote an article for publication on "Epidural Narcotic Administration: Nursing Implications."

School of Law

Professor Larry Alexander completed articles on Dworkin's theory of equality and "state action;" wrote the first draft of an essay on tort theory; and updated research on a book on liberal theory and constitutional law course materials.

Professor Doris Alspaugh compiled ABA Law School Survey results and wrote an article entitled "The Law School Challenge: Are We Ready?"

Professor Barbara Banoff spent the summer as a visiting scholar in residence at the University of Canterbury in Christchurch, New Zealand.

Professor Laura Berend worked on a writing project concerning ethical dilemmas faced by "institutional lawyers" such as public defenders.

Professor Roy Brooks prepared a coursebook for use in a civil procedure course.

Professor Joseph Darby organized materials that could be used to teach a seminar on Soviet Perspectives on the Law of the Sea. He also wrote an article on the Soviet doctrine of the closed sea which was submitted to the <u>Naval</u> Law Review.

Professor Grant Morris did research comparing his experiences as a hearing officer in civil commitment cases with the experiences of non-legally trained court commissioners who performed the same function. He also engaged in some reading on Chinese law in preparation for a legal study tour of China, and completed a final draft of an article entitled "Unravelling an Enigma: An Introduction to Soviet Law and the Soviet Legal System." Professor Virginia Nolan revised a chapter to be included in the Torts Treatise to be published by the Mathew Bender Publishing Company, and began on article analyzing and explaining the significance of Becker v. IRM Corp.

Professor Theresa Player completed a detailed chapter outline for a 3-volume work on California Trial Techniques.

Professor Virginia Shue did research on 174 ABA law schools and wrote an article based on the results entitled "The Law School Challenge: Are We Ready?"

Professor Ed Ursin researched and wrote on tort law and tort reform with Professor Nolan.

On Saturday, November 23, our Foreign Language Department was well represented by Dr. Brigitte Heimers (German), Dr. Jeanne Rigsby and Professor Francoise Demerson-Baker (French) at the fall meeting of the Foreign Language Council of San Diego. Media-related and dramatic activities for the language classroom were presented. The main topic of discussion was the need for preparation of future language teachers. This item will be more and more important as the new language requirement is implemented by the office of the Education Department in Sacramento. Dr. Jeanne Rigsby was asked to take an active part in the elaboration of the program.

Assistant Professor in Theatre Pamela Connolly has been made a founding member of the Episcopal Committee on Scouting by Bishop C. Brinkley Morton. The coat of arms which she has designed for the diocese has been formally received and approved and is being submitted for consideration as an official national emblem for all Episcopal scouts who earn their God and Country Awards.



MEMORANDUM

RE: Tuition Remission

This Memorandum is an <u>Addendum</u> to my Memorandum to both of you, dated July 3, 1985, and subsequently sent by the President to USD Faculty and Staff under date of July 27, 1985, for their information. This addendum should be read in conjunction with my July Memorandum.

I have recently re-read the materials received last winter and spring from the American Council on Education in Washington, D.C. and from the American Association of University Professors. Since that time, there has been no legislative change in Congress. In my July Memorandum, I indicated that the Treasury Department was expected to release a revised regulation on non-discrimination; I have now learned from the American Council on Education's chief legal counsel that Treasury will not issue further regulations at this time.

My chief purpose in writing the current Memorandum is that I found in my re-reading of the ACE and AAUP materials a significant point I simply missed in my earlier analysis. This is not really a new point; it was there all the time, but I did not pick it up. My earlier Memorandum quoted new Section 117(d)(3) of the Internal Revenue Code as stating that a non-discriminatory plan is one wherein the tuition remission "is available on substantially the same terms to each member of a group of employees which is defined under a reasonable classification set up by the employer which does not discriminate in favor of officers, owners, or highly compensated employees." If the plan is qualified, undergraduate tuition remission is tax-free. I have already indicated my best judgment that USD's two tuition remission plans (one for faculty-administration/professionals, the other for staff) would be deemed to be "qualified" plans, and I suggested that USD operate on that assumption. However, and this is the point I missed earlier, if the plan is later deemed not to satisfy the non-discrimination standard, then the tax-free tuition remission will not apply to any officer, owner, or highly compensated employee who benefits from it; all other employees who benefit from qualified tuition remission will enjoy the Section 117(d) exclusion from gross income. To put it another way: violation of the Section 117(d) non-discrimination standard adversely affects only officers, owners, and highly compensated employees. Because Treasury issued no regulations on Section 117(d), "highly compensated" has not been defined. In another provision added to the Tax Code in the same legislation, "highly compensated" has been defined as exceeding 90% of all employees, or exceeding \$50,000 per year.

Finally, my earlier Memorandum noted that tuition remission by USD for employees' spouses and dependent children in post-baccalaureate programs (graduate or professional) was no longer tax free after July 1, 1985. I commented further that "employee assistance programs" under Section 127 remained tax-free until December 31, 1985, when Section 127 expires; though USD's tuition remission plan does not quite fit the technical definition under this section, we have operated on the basis that it is close enough. However, to my knowledge, Section 127 has not been extended by Congress. Unless it is extended, the cost of graduate and professional courses taken by USD employees in 1986 and thereafter will be includable in gross income and subject to income tax withholding and other government-mandated employment taxes.
