A letter was distributed to the USD community in late August regarding a set of guidelines that have been approved to govern the use of the University's logo on printed pieces. These guidelines became effective September 1, 1986.

The guidelines are contained in a manual which has been distributed to department heads and directors across campus. Faculty Handbook:

Revised pages for the <u>Faculty Handbook</u> are attached to these <u>Newsnotes</u> (the 27 un-numbered, 3-hole-punched pages at the back). These revised pages can be placed in the appropriate place in your <u>Handbook</u> after removal of the old sections.

The new pages are Table of Contents/Index (2 pages); Bookstore; Check Requests; Communications/Public Relations (4 pages); Deferred Compensation; Departments (2 pages); Duplicating/Copying (2 pages); Insurance (2 pages); Organizational Charts 4 and 5; Payroll Taxes; Purchasing Procedures (7 pages); Retirement: Phased Option (page 8 only); and Secretarial/Clerical Assistance.

New faculty members may ask their Dean for a $\underline{\text{Faculty Handbook}}$ after September 8.

Sabbatical Leave Requests: Reports on Sabbatical Leaves:

Requests for sabbatical leave in the year 1987-1988 should be submitted by Friday, October 10, 1986. Please follow very carefully the instructions below, so that all sabbatical requests reach timely those whose role it is to deal with them. President Hughes will review the applications with the Provost, the Dean, the department chair (where applicable), and - in summary financial form - the University Budget Committee. He will then submit approved requests to the Board of Trustees at their meeting in the late fall.

Sabbatical leave requests should follow the requirements of the University of San Diego policy (see Faculty Handbook) on sabbatical leave, and should be addressed to President Hughes, but given to the Dean of the faculty member's School/College for checking for completeness, clarity, and eligibility. The request should include a statement about time eligibility for a sabbatical under USD's policy.

Requests should be <u>in triplicate</u>, so that the Dean can forward the second and third copies to the President and the Provost. Faculty members in the College of Arts and Sciences should submit a copy to the department chair as well as to the Dean. Projects should be discussed by the faculty member with the Dean and the department chair at the time of the request, so that they will be able to respond to the President's and Provost's questions concerning the precise nature and the academic quality of the project.

Faculty members and academic administrators who had sabbatical leaves during the 1985-1986 academic year are asked to file their reports, in accord with the USD policy, page 2, by Friday, October 31, 1986.

Dr. Brigitte Heimers, Associate Professor of Foreign Languages and Literatures, spent six weeks of her spring sabbatical in Germany. She received a stipend to attend a Fortbeldungsseminar in Berlin entitled "Berlin und die beiden deutschen Staaten." This seminar on Berlin and the two German states was jointly presented by the Goethe Institute and the Institute for Inter-European Studies. Later on, she visited the University of Munich for the purpose of creating a "Study Abroad Program" for USD students of German. She also toured the University of Tübingen and participated in a seminar on Franz Wedekind.

Dr. Heimers attended a symposium on May 9-10 entitled "The Reception of Twentieth-Century Austrian Culture in the United States" which was held at the University of California, Riverside. It was sponsored by the American Council for the Study of Austrian Literature in conjunction with the Austrian Institute, the Austrian Consulate in Los Angeles, and the Department of Literatures and Languages at UC Riverside.

Associate Dean of Students, Dr. Tom Cosgrove, had an article entitled "The Effects of Participation in a Mentoring-Transcript Program on Freshmen" published in the most recent (March) issue of the <u>Journal of College Student</u> Personnel.

Sister Patricia Shaffer completed her term as Chair of the Sigma Delta Epsilon, Grant-in-Aid Committee which reviewed some 80 applications for stipends (\$750 each) awarded for pre-doctoral research. She has served on this committee for four years, twice as chair. She accepted an appointment on the Development Committee (national) for Sigma Delta Epsilon, Graduate Women in Science.

Sister Shaffer attended the Grand Chapter Meeting in Philadelphia on May 25, 1986, at which this organization celebrated its 65th anniversary. She presented her research "Amidohydrolases Regulated by <u>areA300 in Aspergillus nidulans</u>" at the American Society of Biological Chemists and Division of Biological Chemistry of the American Chemical Society meeting in Washington, D.C., June 8-12, 1986. Furthermore, she was a participant at the Gordon Conference on Fungal Metabolism at Plymouth State College, New Hampshire, July 14-18, 1986.

Irving W. Parker, Coordinator for the Department of Fine Arts, was elected 1986-1987 Vice President of the Associated Community Theatres (ACT) for San Diego County at the General Membership meeting on May 19, 1986. He continues to serve as Parliamentarian and Chair of the Constitution and By-Laws Committee of the Board of Directors.

On May 15, Dr. Dennis Rohatyn, Philosophy Department, was keynote speaker for the San Diego Unified School District at a workshop held at Encanto Elementary School. His topic was "Equity and Fairness in Instructional Practices." On June 4, he gave a paper, "When is a Fallacy a Fallacy?" at the 1st International Conference on Logic and Argumentation held in Amsterdam.

One program from Dr. Rohatyn's <u>The Art of Argument</u> series was picked as a finalist in the most recent Hometown USA Video festival held in Arlington, Virginia. The series placed in the top four nationally in the Innovative: Community Producer Single category.

Dr. Rohatyn's paper "Moore After Eighty Years: Analysis, Common Sense, and the Role of Philosophy" has been published in History of Philosophy Quarterly (University of Pittsburgh), Vol. 3, No. 2 (April, 1986), 207-225.

Dr. Henry Kolar, Fine Arts Department, gave a preview of the music to be presented by the Los Angeles Philharmonic Orchestra at the Civic Theatre on April 19. On May 2, he conducted a string clinic for 40 students from Suaharo High School in Tucson, Arizona, on the USD campus. He also participated in an informal discussion of Czech music with colleagues from the Department of Music at San Diego State University.

At the June 1 meeting of the Southern California Association of Violin Makers, Dr. Kolar played short pieces on 40 different violins, twenty-one of which were made by members of the Association. Mr. Harry Wake of the Association has donated a complete set of his books on violin making to the USD Library.

Dean Ed DeRoche, School of Education, was graduation speaker for flight attendants at PSA. He is chair of the Education Committee of LEAD-San Diego Inc. and co-chair of the Education Committee of the San Diego Bicentennial Commission for the Celebration of the U.S. Constitution. He is chair of the program committee for the fall conference of the California Council of Teacher Education.

Dean DeRoche was interviewed on KFMB radio on July 27 regarding the need for minority teachers and the USD Minority Teacher Scholarship Program. He attended a week-long seminar on international development issues and American Education sponsored by Arizona State University, and gave a talk to the Education Issues class at San Diego State University on the recent report by the Carnegie Foundation entitled A Nation Prepared: Teachers for the 21st Century.

He has had published "Four Topics, Four Views for Newspapers in Education Coordinators" in the July, 1986 issue of <u>NIE Information Service</u>, and "Rebuilding Teachers for a New Age" in <u>The San Diego Daily Transcript</u>, Tuesday, July 22, 1986.

Assistant Professor Pam Connolly, Theatre Arts, was one of four adults to receive the St. George Award, the highest honor in Scouting given by the Catholic and Episcopal Churches. During the summer, she has been working on creating a new program for Cub and Boy Scouts similar to El Camino Real, but tracing the growth of the Episcopal missions in San Diego prior to 1900.

Ms. Deirdre Alfred, Director of the Lawyering Skills I Program, published an article on negotiations entitled "Deal-Making Made Easy" in the June, 1986, issue of the <u>California Lawyer</u>, the State Bar magazine. Also, she participated as a panel member at the Legal Writing Conference in July at the University of Puget Sound. The topic of her presentation was "Current Issues in Legal Writing Programs."
