Dr. Harriet Baber's paper, "Berkeley and the Tattletale's Paradox" appeared in the January, 1989 issue of <u>Idealistic</u> <u>Studies</u>. She presented the following papers at conferences: "Having it All" read at Society for Women in Philosophy, April 16; "Is it Reasonable for Women to be Rational" read at Lake Forest College Philosophy Colloquium, April 25; and "Identity of Indiscernibles" read at American Philosophical Association, April 26, 1989.

Dr. Baber has been appointed to the Committee on Computer Use in Philosophy of the American Philosophical Association and to the Education Subcommittee of the Committee for the Scientific Investigation of the Paranormal.

Dr. James Perry, School of Business, has had a book entitled <u>Using SuperCalc5, 2nd Edition</u> published by Que Publishing, Inc. It is a thorough introduction to spreadsheet design and auditing. The book was coauthored by Joe Lateer.

Dr. Dan Moriarty, Psychology, chaired an invited symposium entitled "Applied Comparative Psychology: Predators and Pets" at the convention of the Western Psychological Association held in Reno in April, and described the role of comparative psychology in the emerging field of applied animal behavior. He coauthored a paper with USD students Michelle Merrigan, Suzanne Moriarty, and Michele Johnson that reported their work on the effects of GABA antagonists on open-field behavior in chicks, which is part of a continuing research program in the psychology department on the neurochemistry of predator defense behaviors. He also coauthored a paper on the combined effects of positive and negative reinforcement on spontaneous alternation behavior with USD students Karen Cadiero-Kaplan and Christie Coleman. Dr. Moriarty represented USD at the meeting of the Association's Council of University Representatives, and chaired the business meeting of the Western Comparative Psychological Association, on whose Board of Directors he serves.

Dr. Mitchell Malachowski, Department of Chemistry, accompanied four chemistry majors who work in his laboratory to the Southern California Undergraduate Research Conference held at UCLA on April 22, 1989. The four students - John Hoffman, Mary Hall, Mike Parker and Dan Davis - presented the results of their Chemistry 199 projects. Ms. Hall won an award for giving the best presentation in her section.

Dr. Malachowski also attended the Third National Conference on Undergraduate Research held in San Antonio, Texas from April 26-28, 1989. This conference brought together over 1,000 teachers and students to present their work and to discuss the current state of undergraduate research.

Law Commencement

Archibald Cox, a leading authority on constitutional and labor law, is Carl M. Loeb University Professor Emeritus at Harvard University. During his career, Professor Cox served as Solicitor General of the United States, Watergate Special Prosecutor, Chairman of the Governing Board of Common Cause, and Chairman of the Health Effects Institute. One of his best-known publications which was co-authored with Derek Bok and Robert Gorman is <u>Cases</u> in <u>Labor Law</u>. This publication is now in its tenth edition.

Graduate School Commencement

Jeanne Quint Benoliel is the first Elizabeth Sterling Soule Distinguished Professor of Nursing and Health Promotion and Professor of Community Health Care Systems at the University of Washington. One of Dr. Benoliel's books, <u>The Nurse and the Dying</u> <u>Patient</u>, was published by Macmillan Company in 1967; in 1982 Hemisphere Publishing Company distributed another book entitled <u>Death Education For the Health Professional</u>. A prolific author, Dr. Benoliel has published articles on diabetic identity, ethical considerations in treatment, women's health and cancer research among other subjects.

Undergraduate Commencement

Herbert G. Klein, Vice President and Editor-in-Chief of the Copley Newspapers, has enjoyed a unique career as a newspaperman, broadcast official, media consultant, a senior leader in the White House, and has participated in five presidential campaigns. More recently Doubleday has published his book <u>Making it</u> <u>Perfectly Clear</u>, a book acclaimed by critics for its hard-hitting definitive look at the love-hate relationship between the media and the Presidents.
