Sabbatical Leave Requests:

Reports on Sabbatical Leaves:

Requests for sabbatical leave in the year 1997-1998 should be submitted by **Friday, October 4, 1996**. Please follow very carefully the instructions below, so that all sabbatical requests reach timely those whose role it is to deal with them. President Hayes will review applications with the Provost, the Dean, the department chair (where applicable), and - in summary financial form - the University Budget Committee. She will then submit approved requests to the Board of Trustees at their meeting in December.

Sabbatical leave requests should follow the requirements of the University of San Diego policy on sabbatical leave, should be prepared following the Guidelines for Preparation of Sabbatical Requests (see *Faculty/Administrator Handbook* for both), and should be addressed to President Hayes, but given to the Dean of the faculty member's School/College for checking for completeness,

clarity, and eligibility. Please refer to the *Faculty/Administrator Handbook* page on Guidelines for Preparation of Sabbatical Requests. The request should include a statement about time eligibility for a sabbatical under USD's policy.

Requests should be in triplicate, so that the Dean can forward the second and third copies to the President and the Provost. Faculty members in the College of Arts and Sciences should submit a copy to the department chair as well as to the Dean. Projects should be discussed by the faculty member with the Dean and the department chair at the time of the request, so that they will be able to respond to the President's and Provost's questions concerning the precise nature and the academic quality of the project.

Faculty members and academic administrators who had sabbatical leaves during the 1995-1996 academic year are asked to file their reports, in accord with the USD policy, page 2, by Friday, November 1, 1996.

Benefits-eligible faculty and administrative employees, rehired for the fall semester, must contact Esther Nissenson at ext. 8762 to schedule an appointment to reinstate medical and dental benefits for the 1996-1997 academic year. Call Vicki Coscia at ext. 8764 to reinstate retirement contributions.

Health and dependent care reimbursement: Receipts or itemized bills must include all of the following information as required by federal law - patient's name, date of service, treatment, expenses incurred, prescription number, provider or store name. Dependent care receipts should show the child's name, dates when care was provided, amount, name and social security number of the provider (social security number is optional). Effective September 1, 1996 Human Resources will return your reimbursement claim when the receipt or bill that is submitted is not complete. Remember, canceled checks and credit card receipts are not acceptable as proof of expenses.

Dr. Mitch Malachowski, Professor of Chemistry, published a paper entitled "The Effect of Ligand Donors on the Catalytic Properties of Metal Complexes. Copper (II) Complexes as catalysts for the Oxidation of 3,5-di-tert-butylcatchol," in the journal *Inorganica Chimica Acta*, Volume 249, pp. 85-92. The paper was co-authored by former USD undergraduates Brian Dorsey and Jonathan Sackett.

In July, USD hosted the Meetings of the Crustacean Society in conjunction with the Third International Large Branchiopod Symposium. These international meetings attracted seventy five scientists from fifteen countries including those as far as Russia, Macedonia, Australia and South Africa. Several researchers from USD participated as well including Marie Simovich (Biology), Michel Boudrias (Marine Studies), as well as Marie's graduate students Cathleen Davies and Jake Moorad. Cathleen tied for the best student presentation.

The meetings included four days of talks and poster sessions along with presentations from the U.S. Fish and Wildlife Service on southern California endangered species protection plans and a panel discussion on international approaches to invertebrate conservation. This event provided an exciting time for the exchange of information and ideas and for the beginnings of new collaborative scientific relationships along with some new friendships.

Marie Simovich and Michel Boudrias organized the meetings, President Hayes hosted a welcoming reception, Dean Drinan opened the meetings with a welcoming address and Associate Provost McGraw closed the meetings with a scientific summary.

Dr. Mary Williams and Dean Ed DeRoche, School of Education, attended a White House conference on Character Education, June 6-8, 1996.

Dr. Brigitte Heimers, Foreign Languages and Literatures, participated in the Eleventh Annual Symposium on Austrian Literature and Culture - Austrian Literature and Cultural Identity, Cultural Policy, Regionalism and "Heimat" - from April 18-20, 1996, at the University of California, Riverside. She presented a paper entitled "Ilse Tielsch: *Die Ahnenpyramide* Eine Familiensaga aus der versunkenen Welt Böhmens und Mährens - Zur Frage des Heimatbegriffes, des Nationalitätenbewußtseins, der Beziehungen zu österreich-." The paper is scheduled for publication in the December issue of *Modern Austrian Literature Journal* or by Ariadne Press, Riverside, respectively.

OFFICE OF STUDENT AFFAIRS**Residence Living Options**

In 1995-96 the Residential Living Options were introduced in the USD undergraduate living areas. The RLOs have enjoyed tremendous success and popularity since their inception, offering opportunities for students with like interests to share a living environment. Each RLO has a faculty/staff sponsor to assist the residents with programming related to their special interest. Some RLOs were so successful that they have been expanded for 1996-97. You will note that several RLOs specifically target the needs of returning resident students, with the goal of promoting retention. Below is a list of the Residential Living Options for 1996-97 along with the sponsors for each. Academic Environment Coordinator

The Office of Student Affairs and the Office of Residence Life are happy to announce the selection of Merrick Marino as the first Academic Environment Coordinator. Merrick's responsibilities will be to conceptualize, promote, and implement various academic, learning support and student recognition programs for students living on campus. This will involve working cooperatively with numerous campus constituencies, including students, resident assistants, resident directors, student affairs administrators, counseling center, career services, tutoring programs, and faculty.

The proposed functions and goals of the Academic Environment Coordinator (AEC) are consistent with research findings which suggest that student learning and development occur across the university community, in and out of class. In essence, the AEC will help to promote a learning environment throughout USD, particularly in locations (e.g. resident housing facilities) and at times (afternoons and evenings) that have been commonly overlooked. The message to students will be that USD is committed to the promotion of student success by overcoming traditional boundaries.

Programs such as study skills workshops, tutoring, "Academic Success Month," and "Faculty in the House Month" are expected to enhance student satisfaction and promote retention.

Faculty volunteers are needed to make presentations and lead discussions on current issues, and to participate in faculty forums and "coffee talks." For more information or to assist the AEC in accomplishing these goals, contact Merrick Marino at 260-4590.

Student Organization Registration

The University of San Diego "recognizes" only student government organizations (Associated Students, the Student Bar Association, the Graduate Education Students Association, etc.). Those student government organizations then "register" all other student organizations under their auspices. Therefore, all undergraduate student organizations are registered with the Associated Students.

Undergraduate student organizations must renew their registration each fall semester in order to continue to receive the benefits which are provided only to registered organizations. This includes the right to use the name of the University, the eligibility to use university facilities, media and equipment, the provision of a mailbox in the student organizations office, and eligibility to receive funding from the appropriate student government association.

If you serve as an advisor to an undergraduate student organization, please advise your student leaders to check their mailbox in the Student Organizations Office (UC113) to pick up information regarding the registration process. A representative of every organization needs to attend one of the registration workshops, offered at two times in Mid-September – locations and dates will be posted in the Student Organizations Office. New organizations can form at any time throughout the academic year – interested students can pick up an "Intent to Organize" packet at the Student Organizations Office. To receive a current list of registered undergraduate student organizations, contact the Student Organizations Office at 260-4802.

As a requirement for registration each year, undergraduate student organizations are required to have a faculty advisor. Advisors are asked to attend meetings of the organization and to assist them with their programming. 1997-98 Fulbright Visiting Scholar-in-Residence Program: US colleges and universities are invited to submit proposals for a Fulbright grant to host a visiting lecturer from abroad. The purpose of the program is to initiate or develop international programs at colleges and universities by using a scholar-in-residence to internationalize the curriculum, set up global studies or area-specific programs, or otherwise expand contacts of students and faculty with other cultures. Grants are for one semester or the full academic year.

Preference is given to proposals in the humanities or social sciences, although other fields focusing on international issues will be considered. Liberal arts colleges, community and junior colleges, and institutions devoted primarily to undergraduate education are strongly encouraged to apply, as are institutions serving minority populations.

1997-98 European Union Scholar-in-Residence Program: Special program to bring officials or academics from the European Union to campuses where there are programs in international affairs, business, political science, or other fields in which an EU official-in-residence would be beneficial.
