ADMINISTRATIVE CHANGES ANNOUNCED FOR USD SCHOOL OF LAW

SAN DIEGO, Calif.--The appointment of an assistant dean and the sabbatical leave of the dean of the University of San Diego School of Law were announced this week.

Herbert I. Lazerow, professor of law, has been appointed to the new position of assistant dean.

Dean Joseph A. Sinclitico, Jr. will be absent on sabbatical leave during the 1970-71 academic year. Professor Joseph S. Brock will serve as acting dean during this period, said the Rev. Msgr. John E. Baer, president of the University of San Diego.

The new post of assistant dean was created to meet the rapid increase in enrollment at the School of Law, Dean Sinclitico said.

Lazerow is legal panel chairman of the San Diego Chapter, American Civil Liberties Union and a member of the Mayor's Social Science Advisory Committee. He is a specialist in federal tax and real property laws.

His new duties will include recruitment, placement, alumni relations and relations with organizations for the legal profession. He will also handle financial aid matters for law students.

He was graduated from the University of Pennsylvania with honors in history, earned his law degree at Harvard Law School and did graduate work at George Washington University Law School. He is a Phi Beta Kappa, and member

of the John Marshall Society.

Author of several articles on the law, he has been at the University of San Diego School of Law since 1967. Previously he was a professor of law at the University of Louisville, and an attorney advisor for the Internal Revenue Service.

Sinclitico will spend his sabbatical in Florence, Italy, working on recent Italian writings in the field of jurisprudence.

Sinclitico holds degrees from Holy Cross and Harvard University. He has been a professor of law at Duquesne and St. Louis University Law Schools, in private practice, a corporate lawyer and university administrator.

An expert on civil procedure, the dean is a member of the American Law Institute. He has been dean of the USD School of Law since 1964.

Professor Brock taught at Creighton and Chicago-Kent Law Schools and was an administrative officer of Stanford University before coming to USD. Brock has also served as chief assistant to the California Commissioner of Corporations and in a supervisory capacity with the Department of Justice. He received his law degree from Stanford and specializes in trusts and wills, administrative law and equity.
