



Re: ADVISOR ALERT: PIN Numbers and Student Addresses

As you know, all student advisors receive list(s) of Personal Identification Numbers (PINs) which advisors routinely give out at the time of advising so that students may access the telephonic course reservation system. That list(s) contains a column labeled "Stat[us]." This column has always been there and shows the "hold code" (if any) that a student might encounter when attempting to reserve classes by phone. In the past, it has shown an "A" if there was an accounting hold, and an "R" for all other holds (disqualification, certain requirements unmet, department holds).

Until now we have not enforced the desired requirement that students maintain a current address and phone number on file with the Registrar's office. However, the Registrar will be adding this expectation to the possible reasons for an "R" guard. It is expected to affect a goodly number of students, at least at first. There are numerous reasons why a current address has become more critical in recent years and the time has come to make sure that our records are up-to-date semesterly for this datum. As an example, students with inaccurate addresses cannot be kept apprised of important information about their status at the University, notification about important changes in such matters at the FERPA laws, etc.

The Registrar/Dean's office will use the "hold" guard to require students to update their address before reserving classes if either office has received returned mail from the address currently on file. The University needs your help in this, so we ask that you please alert student advisees that this new "hold" could appear at the time they attempt to reserve classes. If you let them know of this new requirement when they come to you to get their PIN (and reason for a possible "hold"), which is prior to their eligibility date, it will aid them in not losing their primary window of opportunity to register for classes in a timely manner.

Thank you for your attention to this important matter.
