CHANNEL 4 PRESENTS CONVERSATION WITH ED MEESE AT U.S.D.

On Sunday, June 7, at 11 a.m., KNBC Channel 4's "On Campus" will present a conversation with Presidential Counselor Ed Meese, filmed at the University of San Diego's Joseph P. Grace Courtroom.

Meese discusses the Constitution and the power of the Presidency with Herb Klein, Editor-in-Chief of the Copley Newspapers, and Bernard Siegan, Distinguished Professor of Law at USD. Meese was formerly director of the USD Law School's Center for Criminal Justice Policy and Management. "On Campus" host George Fenneman will introduce the conversation.
