MICHAEL KAPLAN NAMED TO TAX LAW ADVISORY BOARD

Michael Kaplan, president of KB (real estate) Management Co. in Hollywood, has been appointed to the University of San Diego Law School's graduate tax program advisory committee.

Kaplan will serve as an advisor to the graduate tax program, which maintains campuses in Los Angeles and San Diego. He is a 1972 graduate of the law school.
