Alan Morrison and Arthur Shenfield will debate "What is the Best Policy in the Interest of the Consumer - Less or More Government Regulation?" This debate is part of a series of Law and Economic Debates sponsored by the University of San Diego School of Law. It will be held March 16 at 8:00pm in Salomon Lecture Hall. The debate is open to the public; no admission fee.

Alan Morrison, an attorney for the Nader Public Interest Groups supports more government regulation. He received his B.A. from Yale and J.D. from Harvard Law School. Morrison was Assistant U.S. Attorney, Southern District of New York, from 1968 to 1972. Currently Director of Public Citizen Litigation Group, Morrison is a member of the Board of Directors, National Consumer Center for Legal Services and Board of Governors, District of Columbia Bar (Unified).

Arthur Shenfield, Economist and Barrister-at-Law, favors less government regulation. Shenfield is currently Regents' Professor of Economics at the University of California, Davis. From 1949 to 1951, Shenfield was the Economic Advisor to the Government of Trinidad and Tobago. He was Economic Director of the Federation of British Industries from 1955 to 1964 and of the Confederation of British Industry 1964 to 1967. Shenfield was Director of the British Industrial Policy Group 1967 to 1969 and became Director of the International Institute for Economic Research, London, in 1971.

Included in his numerous publications are: The Political Economy of Tax Avoidance, The Ideological War Against Western Society and The Roots of American Discontent. Shenfield has lectured widely on economic subjects in Europe, the United States, Canada, Australia, Mexico, Venezuela and Argentina.
